Subject: REACH Regulation (EC) n. 1907/2006.

Dear Customer,

the Regulation (EC) 1907/2006, known as REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals), lays down the rules for the management of the chemical substances and at the same time it requires constant exchanges of information between customers and suppliers.

We inform you that the company Cogne Acciai Speciali S.p.a ensures the proper fulfillment of all the obligations imposed by the E.U. Legislation, in particular as producer and supplier of articles.

Cogne Acciai Speciali S.p.a. located in Aosta, has carried out the REACH registration of the following substances:

- iron (CAS: 7439-89-6 / EC: 231-096-4);
- chromium (CAS: 7440-47-3 / EC: 231-157-5);
- nickel (CAS: 7440-02-0 / EC: 231-111-4);
- molybdenum (CAS: 439-98-7 / EC: 439-98-7);
- cobalt (CAS: 7440-48-4 / EC: 231-158-0)

in case it is an importer and/or a manufacturer.

The interpretation of the Regulation REACH, document “Guidance on requirements for substances in articles” by ECHA, defines our products as:

- articles under REACH, therefore not subject to the registration of the constituent substances.

In accordance with the article 33.1 of the Regulation REACH, we report that, in the articles supplied by us, none of the substances SVHC (Substance of Very High Concern) introduced in the Candidate List (available on the ECHA website at: <https://echa.europa.eu/it/candidate-list-table>) through Decisions (including Decision D (2025) 4165-DC) is present in concentrations equal to or greater than 0.1% by weight.

We also communicate that, in the articles supplied by us, none of the substances SVHC (Substance of Very High Concern) introduced in the Annex XIV (Authorisation List) through Regulations (including Regulation UE 2023/2482) is present in the articles supplied by us. Consequently, there is no obligation for Cogne Acciai Speciali to make notifications at the SCIP database of ECHA, in compliance with the provisions of the EU Directive 2018/851.

Given our constant commitment to comply with the current regulations, it will be possible for you to continue to get supplies from our Company and its commercial network without any problem, in accordance with the REACH Regulation.

We assure you that we will keep you informed of the next requirements imposed by the regulation, in order to ensure the compliance with the requirements and the involvement of the downstream users of our products.
